#### A new regulation hurts PSWS.

Ontario is hurting personal support workers (PSWs) with a new regulation that denies them basic legal rights.

Every other regulated profession (nurses for example) has an independent process for dealing with malpractice complaints, which is subject to the basic standards of law and also subject to appeal to the courts.

None of these features are being applied to PSWs, which means that they could lose their license to practice and have no ability to appeal the decision. Effectively they could be prevented from ever working as a PSW again and have their reputation badly hurt. We are organizing a lobby effort to push for real legal protections for PSWs.

### OCHU-CUPE study highlights the shortage of hospital beds and the desperate need for more staff

Ontario needs to add 16,000 new hospital beds and fill the 25,000 vacant positions in our hospitals over the next 10 years, a study released by the Ontario Council of Hospital Unions- CUPE found.


The study was released over the month of August in 20 Ontario communities.

The Ontario government plans to add just 3,000 beds over 10 years

CUPE estimates that the cost of adding the new beds and staff would be an additional \$2 billion a year.

Ontario is facing a tidal wave as the baby boom generation ages, as our population grows and as medical advances mean that people can live much longer with conditions which would have been fatal 10 or 20 years ago.

The Ontario government promised to end hallway medicine during the last election campaign. But there are now more than twice as many people on stretchers in hallways in 2024 as there were in 2021.
